- predict the causes and estimate consequences of criminal activity, use the principles of crime prevention.

The graduate is employed in the middle management positions in the fields where the work activity linked to the knowledge and proper application of the legislation of the Czech Republic in matters of public order and internal security, in work activities related to work in the security forces, public administration in Protection Department of large enterprises, banking, insurance business, in the organs of the Integrated Rescue System.

Examples of possible job positions: security officer, a police inspector, municipal police constable, customs officer, security officer in the prison service or guard or judicial guard officer.
