- comply with the principles set for the various activities of professional services in the fire protection;
- manage and organize the maintenance and repair of equipment used in the FRS;
- have a good command of the constructional design of the technique used in the FRS, the electrical equipment and accessories:
- use the various information resources, such as technical drawings and schemes occurring in the instruction manuals for the equipment and machinery, service manuals, instructions, etc.;
- use the information and communication technologies in the organizational and operational management.

The graduate is employed in the in units of fire protection in the area of fire prevention, protection of the population, in the performance of special services.
